nycobalNOMA was initially formed in 1970 as the New York Coalition of Black Architects (NYCOBA) and joined with NOMA in the fall of 1992 to become the national organization's New York Chapter. nycoba|NOMA supports the interests of professionals, educators, and students engaged in the process of designing, regardless of their position in the long arc of their careers. The organization is committed to increasing the representation of minority architects in the profession and supporting the interests of those from other disciplines, professions, and businesses who share our commitment to advancing the value of design and our roles in it. The organization is committed to stimulating thoughtful discussions about our roles in design through conferences, competitions, exhibitions, publications, and websites.

#### **AIA New York Diversity and Inclusion Committee**

The AIA New York Diversity and Inclusion Committee seeks to provoke dialogues about diversity and give agency to issues of inclusion and representation. Today, the architecture profession is undergoing important changes, rethinking its position in relation to challenges like climate change and energy consumption and how design can impact health. The practice's shifting cultural landscape requires all of us to diversify. In 2008, the AIA National Board of Directors recognized that a key strategic initiative required the enlistment of "new talents and new insights to address the critical issues of our time and future generations" to create a "strengthened, more highly valued, and esteemed profession capable of reaching into constituencies previously underserved." The local committee's role matches that of the Diversity & Inclusion Council at the National level, turning toward action items and ideas that promote diversity.

#### J. Max Bond Center for Urban Futures (JMBC)

The J. Max Bond Center for Urban Futures (JMBC) is a City College of New York Applied Research Center located within the Spitzer School of Architecture. JMBC aspires to create equitable and just urban futures that foster individual and communal success. 

# J. MAX BOND, JR. FUND



The J. Max Bond, Jr. Fund supports programming in honor of J. Max Bond, Jr., FAIA, NOMA, (1935-2009) an African American architect, global citizen, and activist who made trailblazing contributions to the profession and beyond. He was a partner at Davis Brody Bond and former Dean of the City College of New York School of Architecture and Environmental Studies. The J. Max Bond Jr. Lecture was founded in 2010 as a collaboration between the New York Chapter of the National Organization of Minority Architects (nycobalNOMA), the American Institute of Architects New York (AIANY) Diversity and Inclusion Committee, and the J. Max Bond Center for Urban Futures at the City College of New York. After years spent gathering the support and attention of AIANY members and the broader architecture and design community, the fund became endowed in 2021. The fund's inaugural lecture series and future initiatives aim to enhance Bond's legacy by producing collaborative programming that elevates contemporary voices and addresses issues related to equity, underrepresented communities in design, and global cultures—particularly those of Africa and the African diaspora. These causes were fundamental to Bond's own life, both while he worked in New York City and during a three-year period he spent stationed in Ghana.
